Board Letter about 4th Edition Blue Book

October 12, 2007

Dear RCA Fellowship,

Due to the temporary status of this 2006 DRAFT edition, and the fact that it was intended only for feedback and development, it will no longer be made available for purchase in book form after November 1, 2007. A printable PDF version of the 4th Edition 2006 Draft can be purchased from the WSO for \$5.00.

We intend to have a final revised and edited 4th Edition 2008 Blue Book to disseminate to all RCA groups by April 2008 for Fellowship vote and approval. Once this version is approved it will become the 2008 Fellowship-approved RCA Blue Book.

In the meantime, we recommend that while waiting for publication of the 4th Edition 2008 Blue Book, groups can purchase the 1996 3rd Edition of the RCA Blue Book, which at this time is the only RCA approved book. It is available for \$12.

7th Tradition Committee continued

Here are some of the things we talked about regarding past and future financial commitments that we all owe to RCA:

1. **Keep the WSO office open.** We have had to cut the Office Manager's hours. In some months, usually before and after the convention when sales and donations were low, we had to defer paying the Office Manager and some bills until we had enough money. Besides giving the OM more hours to carry the RCA message, it would be great if we gave him a long deserved raise. We should at least be able to send him to the RCA convention. I feel sad that the World Service Office couldn't afford to send Steve to Boston and St. Louis to experience the tremendous amount of effort by RCA groups to be informed, and to make informed decisions for the future of RCA.
2. **Build a prudent reserve.** Don't we all want that for RCA? We all have experienced rainy days. If there are too many rainy days in any 12-step program, the message stops going out.
3. **Fourth Edition of the Blue Book.** The Literature Committee is working very hard to bring a 4th edition DRAFT to the fellowship by Spring 2008. If approved by the fellowship, the intention is to publish it for the 2008 San Francisco Convention, August 1-3. For that to happen, WSO will need about \$1500 for an editor, \$5000 to publish enough copies to sell over a year, and about \$2000 for a prudent reserve.

Here are some ideas the committee explored. We hope they inspire you:

- **Special occasion cards.** Alexandra is willing to make these up for a couple's anniversary together, birthdays, RCA birthdays, Valentine's day, etc. Couples that feel particularly generous on that special day might make a gift to RCA. A special card of gratitude would be sent.
- **Pass the hat for WSO once a month.** There are about 120 RCA groups. Our challenge to all of you would be to give \$60 per couple per year (that's only \$5 per couple, per month) to WSO. That would contribute to RCA being self supporting.
- **Buy a classic.** Did you know that there are over 800 copies of the time-honored classic, 1996 3rd Edition Blue Book in the World Service Office? This edition was used for the first 18 years of RCA, and costs only \$12. It was reprinted after the Boston convention, when the majority of delegates passed a motion to do so. If they were all sold, that would generate \$10,000.
- **Have a retreat or workshop.** Extra funds raised could go to RCA. This is already being done in Sweden and California, where they send funds left over, and donations generated, to the WSO. Thanks to RCA groups who do that!

7th Tradition Committee summation

We'd like to hear about your 7th tradition ideas. We'd like it even more if you tried them out and let us know how they worked!

One of the last things we talked about was touchy, but we felt it needed airing. The general consensus of the committee was to encourage all contributions to go into WSO general revenue. We know that there has been a tendency in RCA for some to designate contributions for specific things. I can honestly say that the Board and the WSO will do their utmost to honor your wishes. But please put PRIDE and EGO aside, and trust in the Higher Power as expressed in the groups' consciences and committees.

Have fun carrying the RCA message. There are always new couples out there looking for a better way than slamming doors and having shouting matches.

Our thanks to the Group Contact Couples and to Outreach for getting the message out that RCA needs to be self-supporting through its own contributions. Thanks to Elise W. and JoAnn S. who give back to RCA by volunteering in the WSO office. Thanks to RCAers that give back to RCA by serving on committees. Thanks to RCA groups that give back to RCA by contributing through the 7th Tradition.

Do You Need a Meeting?

"Do you need a meeting?" Many of us have asked our partners or ourselves that question in times of stress. That was just our impetus for

starting a new RCA fellowship in our town of Santa Rosa, California.

First, a little background: it was mid-April of this year and it seemed like David and I had been moving for weeks. Our garage was still not painted, and our living room was piled high with furniture and boxes from the larger house we'd just left. Every day, all day, we spent packing and unpacking, cleaning and organizing. We were both so tired that intimacy had begun to seem like a chore. Conversations became terse exchanges of facts, and some rude words (and gestures) were exchanged as well.

In the middle of this David received a call from our friends Terry and Laurie. We had participated in RCA with them in a neighboring town. When that meeting broke up David immediately sent for a meeting starter packet from WSO, but we'd somehow never gotten around to calling a meeting. But that day when Terri asked, "Do you guys need a meeting?" we jumped at the chance.

The meeting worked its usual miracle as we were able to air our stresses in a safe space, and since then we've barely missed a Saturday. Although we are still only four we remind ourselves of Chapter 11 of AA's Big Book, which tells how one member became two, became three, became four. Now there are over 2 million members of AA. Our fellowship is still young and small, yet we are hopeful that we will continue to grow. Meanwhile, we remind ourselves that it takes only two couples to create fellowship.

A Reflection on the St. Louis RCA Convention

We have been attending face-to-face RCA meetings for just over a year. We found the atmosphere of caring, compassion, and acceptance to be invaluable in our recovering couple-ship. Attending the annual convention in St. Louis this summer only added to our deep appreciation of this program.

We came as nervous newcomers, not sure what to expect. We found an abundance of experience, strength, and hope from couples in all walks of life: young, younger, and not so young couples; shy, outgoing, married, committed, and life partners; couples new to recovery and experienced 12-steppers alike! We found couples with the same thoughts, the same fears, and the same issues and stumbling blocks that we face each day. There were new ideas, and reminders of old ideas we had long forgotten or lost faith in. There were couples glowing in recovery and love, and couples who were hanging on with their last ounce of strength. There was joy and trepidation, fear and amazing courage.

All around us we found HOPE! It was there in the couples who came to the convention as their very first RCA experience. (What a leap of faith!) It was in the words of the lead couples for the breakout sessions as they told their stories and in the faces of the couples in the rooms as they related what they heard to their own lives. And it was in the voices of couples deep in pain as they asked for ESH. It was in the very air, like the energy from a thunderstorm! It was pouring from the couples as they spoke of the rewards they had received from working all three legs of their stool! I only wish we could bottle the spirit of recovery that was alive in that hotel and I would wear it around my neck all the time.

Meeting and talking with couples out of the

rooms only added to our experience. We had a few wonderful outings with several different couples throughout the weekend and into the next week. New friends and great memories. Lessons learned, feelings validated. Experiences shared, new ideas sparked. Tools introduced and tried, commitments reinforced. Even the reminder that painful lessons are a gift from our Higher Power, too. What we received from this weekend has only been positive and will remain with us for a long time.

Office Overview Committee Year One:

For the first time in a few years, the RCA Board established an Office Overview Committee to act as liaison and support for the office and office manager. The Board also approved that most members may be from the Bay Area Fellowship, in

order to meet regularly and be physically available for office activities and needs. We hope the OOC will retain people over several years as newcomers come on, learn about the WSO, and help provide continuity for RCA's fellowship.

Accomplishments:

Bob F. is now authorized to sign checks on RCA's account. Elise has a key to the office and post office box, and is learning how to navigate the computer set-up. She is already able to process literature orders and make deposits into the bank account when the Office Manager is away.

Things still on our plate:

We began merchandise inventory, but this is on hold, and hasn't made it onto our quarterly or annual reports yet Treasury couple can read bank account balances online. We still need the ability to monitor checks being written, i.e., how much, to whom, and when.

The Office Manager is still working mainly alone, and making decisions without committee knowledge or input. We hope OOC can set up a workable structure to have more transparency, better distribution in decision-making, and have that knowledge shared with fellowship representatives on the Board and Committees.

At this time the Office Manager writes his own paychecks. We recommend that Bob F., as signatory on the checking account and a representative on the OOC, sign the Office Manager's checks each month, giving them a time to meet and assess needs, duties, and upcoming deadlines with the OM on a more regular basis. This may also help OM retain his status as a consultant.

The Board Chair has asked us to go over the details of the office lease. We are not sure we have the expertise for this, but at this point it might be good not to have a lease, as we are so close to the bare bones in meeting our WSO expenses.

The Treasurer and Office Manager set a WSO expense

budget this year and it was used in the Treasurer's quarterly and annual report. The Treasurer has recently given WSO a one-page, monthly budget sheet as a working document, but it has not yet been utilized.

(UPDATE: The OOC met October 2, 2007 in Oakland. The Treasurers and the OM have spoken with a bookkeeper in the Oakland Area. Our goal is to have a lower cost performance of Quick Books tasks, provide accurate quarterly reports, and use our database in a more comprehensive and efficient way, giving the OM more time for tasks that are specific to the RCA fellowship. The OOC agreed there was enough promise to have more talks with the bookkeeper, and a trial run for a few months. At the end of that time the committee will review whether the use of a bookkeeper is a cost effective investment.

Bob F. is now meeting monthly with the OM, and signing his paychecks. Bob also volunteered to work with the OM and manage an updated meeting directory that would be available more frequently.

The Treasury couple and the OM have developed new templates to provide financial transparency. This will allow us to see at a glance how much cash WSO has available to spend and budget, as well as to track funds for a specified use, e.g., the Blue Book printing fund or editing fund. This way, members of the Fellowship can be assured that contributions for a specific use will be saved and spent only for that purpose. - ed.)
