Chair Report - January 2012

Hello Everyone! I am Ruth in loving Recovery with Debbie and am honored to serve as the Trustees Chair for the service year of 2011-2012. 2011 was full of new ideas and wonderful things in our fellowship. I want to take this opportunity to share and celebrate the highlights of this past year in RCA.

Early in the year, we had a Fellowship vote that made our 4th edition of our blue book the first "Fellowship Approved" book that we have. It brought together years of work by faithful volunteers. Our literature committee worked incredible hours editing – page by page – to get the final book. On behalf of the Board and the Fellowship, I want to again offer our thanks and appreciation for the hours and work. I would also like to acknowledge the production committee who took that final draft and delivered it to our merchandiser.

We had an awesome convention in Phoenix Arizona! Our Arizona members did a great job of pulling together a wonderful weekend of recovery workshops and great fellowship. The accommodations were awesome, the workshops fun and informational, and after all of that they were raised over twelve thousand dollars for the World Service Organization. Thank you again, Phoenix! If you want to hear or share some of the workshop's experience, strength and hope, they are available on our web site, along with 2010's CD's from Niagara Falls.

We also accomplished a complete overhaul of our web site. The technology committee and the newly formed web team selected a contractor, laid out the requirements and delivered a new and improved web site.

One of its new features enables each group contact couple to autonomously be able to edit and update its own information, expanding the options in the on-line store and a fellowship discussion board that should be active for this year's convention and fellowship voting items. A note on the value of change: The web traffic has quadrupled since the new site went up!

We had some Trustees rotate off the Board, and some new ones stepped up to service. Your WSO Board of Trustees now has eight committed couples serving the Fellowship. We meet every month, and would love for couples to join us and listen in on the board meetings. We are reviewing the work by our contractors and committees, keeping up on issues and ideas for the Fellowship and drafting and reviewing concepts of service that we hope to bring up for fellowship approval at the next Annual Business Meeting. Please see our on-line calendar for details on how to join our meeting.

From our Business meeting in Phoenix, we have created three focus groups working on issues the fellowship said it wanted. One is on the care and shipping of our convention banners, one is called the Angel Guardians and focused on how to support our member couples in crisis, especially losing a partner to death, and the third is forming a comprehensive policy to define meeting requirements that can be posted on our web site and in our literature to address the needs of different meetings. There has been a list of couples who needed sponsors kept for many years. This year, however, the position of list keeper was taken by a board member and the response has been phenomenal! Dozens of couples have been matched up with sponsor couples, and a waiting list has been established for those still looking for help. The only requirement is a desire to help others work our RCA program – and you only need to be one step ahead of your sponsees! Speaking of working the steps, we have also started the first phone step study this year. We have had a great response and hope that many others will join in. It is the 4th Sunday of each month, and details are on the web site. You can also email <u>Growing-The-Fellowship@recovering-coules.org</u>. You don't need any experience to "step" into a meeting, and it is a great way to spend a Sunday afternoon with your partner in recovery. The plan is to begin it again after the annual convention this year.

There have been many other things that your board of Trustees and its service committees have done and are doing. We hope that with this New Year, couples will consider service in committees or on the board itself. Service is our 12th step work and it gives so much back to those who are willing to work.

This year should prove to be even more exciting! Our annual convention will be in Memphis Tennessee in August, 2012. It is going to be a fun and informative gathering – and we can't wait to see the workshops and fellowship they are planning for us. Please be sure to mark your calendars and come join us there. If you have NOT been to an annual convention, it is an amazing boost to a couple's recovery and a wonderful way to learn and grow. See you there!

Speaking of the annual convention, the annual business meeting is the Friday of the convention. It is a great time to see how things are working and to have a part in YOUR fellowship. And – this year there will be a "free lunch"! Yes – the Board has agreed to furnish all those attending the meeting a buffet lunch. It will give us some more fellowship time, time to meet and talk to the board and it will also acknowledge those who are willing to show up in service for the fellowship.

We are also working on other projects and ideas: We are forming "Country Contact Couples" to help us reach other countries and languages. We are creating packages to go out to the media and to therapists and professionals to help spread the word about RCA. The first RCA Daily Reader book is being created. We are finding and producing more tools, recordings and information to help expand our recovery as well as our fellowship. Other projects are brewing and we would love to hear more ideas from YOU!

We are wishing you a wonderful year ahead and look forward to being a part of your recovery!

We are Ruth & Debbie in a loving and committed relationship together. We want to share with everyone one of our most frequently used tools for working the steps. This came to us from our loving and giving sponsor couple at a time that we needed it the most. We have shared this many times with our sponsee couples and our home group, and now with all of you.

Working the Steps:

What is the unmanageability you are experiencing in this situation?

Believe that your higher power can restore you both to commitment and intimacy.

Make a joint decision to turn the problem over to your coupleship's higher power (and be open to the promptings).

What character defects do you each have that bear on this problem?

Are you ready to have Higher Power remove these?

Ask Higher Power to remove these defects of character, communication and caring.

Do you need to make an amends to each other? If so, follow through with it.

Determine how you can use step 10 to follow through because planning and scheduling will be an ongoing process.

Improve your conscious contact with Higher Power, praying for knowledge of Higher Power's will as it applies to this situation.

Allow your spiritual awakening to help you carry this message and practice these principles in all aspects of your lives, your relationships and families.

This is a beautiful example of the gifts we receive with sponsorship. At this time there are MANY couples waiting for and praying for the gift of a sponsor couple. If you are willing to share your gift of recovery, please email sponsors@recovering-couples.org.

RCA DAILY READER SUBMISSION INSTRUCTIONS

These instructions are meant specifically for the completion of submissions to be considered for the RCA Daily Reader......a compilation of 366 submissions to provide inspiration, instruction, experience, strength, hope and faith from our fellowship members to our fellowship members and couples who continue to suffer in dysfunctional or abusive relationships.

- 1. The form offers three possible dates for you to choose on which your submission will appear, such as an anniversary, a birthday, the date of your first Meeting, etc. If by the time you submit, those dates are taken, we will offer you the opportunity to suggest three more. We hope to offer a calendar of populated dates as submissions pour in so as to avoid duplication. The 366th day, February 29, will be used as an example for submissions.
- 2. Your submissions are subject to edits based on appropriate length and subject. The committee hopes to limit editing to a minimum, thereby allowing the creative spirit of our fellowship with the guidance of a power greater than ourselves to create this useful tool.
- 3. We will add to the WSO website PDF's to allow for easy submission and subsequent transmissions to DailyReader@recovering-couples.org for committee review and approval. Please include your e-mail address or phone number in the event that we need to contact the submitter for clarification.
- 4. This committee does not have a timeline for completion of the book. That end date will be entirely in the hands of the fellowship. The Daily Reader subcommittee will submit the final product to the Literature Committee for approval, which in turn will review the book and submit it to the WSO Board for final approval prior to publication.
- 5. All submissions are subject to a first-submitted, First-served basis. See below as an example of a submission.
- 6. All submissions become the property of RCA for use in the Daily Reader publication.
- 7. Submissions may be quotes from other sources or original thoughts. Quoted authors need to be included as part of the quote/poem/song.
- 8. It is suggested that both the Reflection and Response (see sample below) be written in the voice of the "we" to acknowledge our coupleship.

Today's Thought: Leap Year Day is about correcting the imperfection of our calendars. It proves in an odd way that even our solar system is not perfect, but that it can be adjusted and corrected.

Reflection: Our Program suggests that we make corrections, amends, to turn our wills and lives over, and to do this one day at a time. We cannot wait for every fourth year, but then again, we are not as big as the universe. We try to make our

corrections "wherever possible except when to do so would injure them or others."

Today's Response: Today, we will strive as a recovering couple to work our program and to take a "Leap of Faith" into action. A meeting for two, a meeting, a call to a sponsor couple, prayer and meditation, checking in on time, sex and money, sharing our feelings. We will do whatever it may be to work our program.

HERE IS A SAMPLE THAT HAS BEEN SUBMITTED

Our Daily Reader Experience!

Part of our 11th step every morning is sitting together. We alternate reading from inspirational readings from various 12 step daily readers. We then sit quietly together, in meditation, for 5 minutes, then share our thoughts and inspirations. When we heard that RCA is creating a daily reader, we were thrilled to know that one day we would have THAT treasured tool for our morning ritual.

We decided to honor our coupleship, by submitting an entry for the date of our anniversary. We used the submission form from the RCA web site (under group resources), and together we created what we wanted to share. We sent it into DailyReader@recovering-couples.org and the committee reviewed it and told us we could have our selected date! We are going to be part of the RCA Daily Reader – and so can YOU!

We would like to share our submission with you:

Thought for this day: In Sedona, Arizona, there is a rock formation of a couple standing back to back during their wedding ceremony. Legend says that the couple was from different Native American Tribes, with different views and histories. With their unique vantage points, each could see what the other could not. The elders witnessing the ceremony reminded them of the growing strength in their differences.

Reflection: We each come from different families of origin and have different traditions, beliefs, experiences and perspectives. Just like the couple back to back, we may never see the same things or share the same perspective.

In recovery, we learn to invite Higher Power into the unity of our coupleship to help us see the bigger picture and to realize that there is greater strength within the spectrum of our differences. Together we can see, do and imagine much more than we could ever do alone.

Today's response: Today in our coupleship recovery we can respect our differences and perspectives and have the willingness to consider that Higher Power has a broader view. It is this broader view or third way that is possible by us being willing to be willing.
